<p><b>TIME WEIGHTED AVERAGE EXPOSURE LIMIT</b></p> <p>Xenon is defined as a simple asphyxiant. Oxygen levels should be maintained at greater than 18 molar percent at normal atmospheric pressure, which is equivalent to a partial pressure of 135 mm Hg (ACGIH 1990-1991). OSHA 1989 does not list a TWA for Xenon.</p>
<p><b>SYMPTOMS OF EXPOSURE</b></p> <p>Effects of exposure to high concentrations so as to displace the oxygen in the air necessary for life are headache, dizziness, labored breathing and eventual unconsciousness.</p>
<p><b>TOXICOLOGICAL PROPERTIES</b></p> <p>Xenon is nontoxic but the liberation of a large amount in a confined area could displace the amount of oxygen in air necessary to support life.</p> <p>Xenon is not listed in the IARC, NTP or by OSHA as a carcinogen or potential carcinogen.</p> <p>Persons in ill health where such illness would be aggravated by exposure to Xenon should not be allowed to work with or handle this product.</p>
<p><b>RECOMMENDED FIRST AID TREATMENT</b></p> <p>PROMPT MEDICAL ATTENTION IS MANDATORY IN ALL CASES OF OVEREXPOSURE TO XENON. RESCUE PERSONNEL SHOULD BE EQUIPPED WITH SELF-CONTAINED BREATHING APPARATUS.</p> <p><u>Inhalation</u>: Conscious persons should be assisted to an uncontaminated area and inhale fresh air. Quick removal from the contaminated area is most important. Unconscious persons should be moved to an uncontaminated area, given assisted respiration and supplemental oxygen. <b>SPECIAL HANDLING RECOMMENDATIONS</b> Use only in well-ventilated areas. Valve protection caps must remain in place unless container is secured with valve outlet piped to use point. Do not drag, slide or roll cylinders. Use a suitable hand truck for cylinder movement. Use a pressure reducing regulator when connecting cylinder to lower pressure (<3,000 psig) piping or systems. Do not heat cylinder by any means to increase the discharge rate of product from the cylinder. Use a check valve or trap in the discharge line to prevent hazardous back flow into the cylinder.  For additional handling recommendations, consult Compressed Gas Association's Pamphlets P-1, P-9, P-14, and Safety Bulletin SB-2.	
<b>SPECIAL STORAGE RECOMMENDATIONS</b> Protect cylinders from physical damage. Store in cool, dry, well-ventilated area away from heavily trafficked areas and emergency exits. Do not allow the temperature where cylinders are stored to exceed 125F (52C). Cylinders should be stored upright and firmly secured to prevent falling or being knocked over. Full and empty cylinders should be segregated. Use a "first in - first out" inventory system to prevent full cylinders being stored for excessive periods of time.  For additional storage recommendations, consult Compressed Gas Association's Pamphlets P-1, P-9, P-14, and Safety Bulletin SB-2.	
<b>SPECIAL PACKING RECOMMENDATIONS</b> Xenon is noncorrosive and may be used with any common structural material.	
<b>OTHER RECOMMENDATIONS OR PRECAUTIONS</b> Compressed gas cylinders should not be refilled except by qualified producers of compressed gases. Shipment of a compressed gas cylinder which has not been filled by the owner or with his (written) consent is a violation of Federal Law (49CFR). Always secure cylinders in an upright position before transporting them. NEVER transport cylinders in trunks of vehicles, enclosed vans, truck cabs or in passenger compartments.
